Title: Consultant Services for Education System Assessment and Business Case Development

INTRODUCTION

Maskwacîs Education Schools Commission seeks proposals from qualified consultants to conduct a comprehensive assessment of our education system, identify areas of need, and develop a business case for addressing these needs.

For 129 years, residential schools were an attempt by the Government of Canada to assimilate First Nations people. There was a mission school in Maskwacîs as early as 1894 known as Ermineskin Indian Residential school for the period from 1916 - 1975 and from 1975 until 1990, the Canadian Government assumed the responsibility for running Ermineskin Schools.

Maskwacîs began collaboration between the four existing school districts of Louis Bull Tribe, Ermineskin Cree Nation, Montana First Nation and Samson Cree Nation to examine ways of improving student achievement and taking ownership of its own school system. Through the spirit and intent of our Treaty right to education, Maskwacîs united to develop a Maskwacîs Education Law and the Maskwacîs Cree Declaration on Education to move this vision forward.

In 2017, Maskwacîs amalgamated eleven schools from four separate education authorities to create the Maskwacîs Education Schools Commission otherwise known as MESC. MESC is located on Treaty No. 6 Territory in central Alberta and has been delegated the responsibility of operating and maintaining all Maskwacîs schools, other education facilities and education capital assets that are located on reserve or are property of the participating First Nations. Currently, MESC operates and manages ten school programs and twenty buildings, with approximately 510 employees and a budget of \$75M annually.

MESC believes the main step that Canada can take to uphold the spirit and intent of our Treaty right to education is to properly fund schools controlled by First Nations communities. MESC exercises the Treaty right to education by prioritizing Cree culture, language, and traditions into the school with emphasis on lyiniw Mamitonehiciken, Nehiyawewin, Nehiyaw Pimatisowin and Wahkohtowin.

OBJECTIVES

- Assess the current state of the Maskwacîs Education Schools Commission system.
- Identify key areas requiring improvement or development to address gaps.
- Develop a detailed business case outlining recommendations and strategies for improvement.

SCOPE OF WORK

Working closely with the MESC Board of Governors Negotiations Committee and administrative team, the consultant will:

Assessment:

- Evaluate the current education system including; curriculum, teaching methods, student outcomes, infrastructure, organizational structure, Board policies and administrative procedures, Maskwacîs funding model, and planning and budgeting procedures.
- Collect and analyze data from various stakeholders (students, teachers, administrators, parents/guardians, Maskwacis Chiefs and Councils).
- Identify strengths, weaknesses, opportunities, and threats (SWOT analysis).

Needs Identification:

- Determine critical areas of need and gaps based on assessment findings.
- Prioritize needs based on impact and feasibility.

Business Case Development:

- Propose actionable recommendations to address identified needs.
- Develop a detailed business case including:
 - Executive summary
 - Problem statement
 - Recommendations to address needs and gaps
 - Objectives and outcomes
 - Cost-benefit analysis
 - Analysis of all feasible funding models with cost benefits
 - Risk assessment and mitigation strategies
 - Implementation plan

DELIVERABLES

- Comprehensive assessment report
- SWOT analysis
- Prioritized list of needs
- Detailed business case with list of recommendations

PROPOSAL REQUIREMENTS

Proposals should include the following information as a minimum:

- Contractor/Company profile, relevant experience, address and contact details
- Demonstrated knowledge and expertise working with First Nations organizations
- Team composition and qualifications
- Methodology and approach
- Work plan and timeline
- Detailed cost breakdown
- Payment terms
- Disclosure of any other actual or perceived conflict in the acceptance of the appointment as consultant

EVALUATION CRITERIA

Proposals meeting the mandatory requirements will be assessed against the evaluation criteria indicated below:

- Relevant experience and qualifications
- Methodology and approach
- Proposed timeline
- Cost-effectiveness
